What is Title I?

- Title I is a K-12 federal program that provides additional academic support and learning opportunities for students at schools and districts with high percentages (above 40%) of socio-economically disadvantaged children. The program is intended to help ensure that all students meet state academic standards.



Goals of Title I

- Identify students experiencing academic difficulties and provide assistance to help these students
- Purchase additional staff, programs, materials, and/or supplies
- Conduct parent and family engagement meetings, trainings, events, and/or activities



FAMILY ENGAGEMENT

The administrator, parents, staff and community will strategically plan and implement Title I requirements according to the guidelines set forth in the law which include the following:

1. Making parents aware of ESSA and the school's participation.
2. Inform parents of their right to be involved by observing the school's program(s), volunteer, and visit classrooms.
3. Providing parents with student information and progress reports.
4. Inform parents of opportunities for regular meetings. To ask parents and community for feedback and suggestions at parent meetings on issues and decisions relating to the education of their children.
5. Providing parents with a copy of the Family Engagement Plan.
6. Providing parents with a description and explanation of curriculum, academic assessments used to measure student progress, and the proficiency levels students are expected to meet.

Parent Conferences

- Rozelle Elementary will hold Parent-Teacher Conferences on Thursday, September 5 (4-7p) and Thursday, February 13 (4-7p).
- Parents may request conferences with the teachers throughout the year.

Reporting Pupil Progress

- Grades are posted in PowerSchool for Parents weekly.
- Weekly folders are being sent home on Wednesdays.

Newsletters and Calendars

- Teachers will send weekly newsletters that contain information about the upcoming weeks' skills, assignments, and important announcements.
- The school has a monthly calendar so you can keep up with school-wide events.
- All school social media account are updated as new information becomes available.

EXPECTATIONS

Rozelle Creative and Performing Arts Elementary School expects parental involvement in the educational process. The school and home cooperatively share the goal of promoting success in our children. Our parents will assume the roles of advisors, resource persons, and coordinators by doing the following:
