

The American Academy of Pediatrics released new COVID-19 guidance for schools that supports in-person learning and recommends universal masking in school for everyone over the age of 2, regardless of vaccination status.

### **Continued Protocols**

### Masks

 Masks should be worn indoors (schools) and on buses by all employees and students, regardless of vaccination status until further notice.

#### Water

- Bottled water will be provided and students are strongly encouraged to bring water containers. **Social Distancing**
- Students will socially distance to the extent possible in classrooms, hallways, common spaces, when moving through the food service line, and while eating.

### **Updated Protocols**

### In-Person School Activities, Sports/Extra Curricular

- School activities for employees and students (before, during, and after school), including athletics, will
  resume, and participants will follow District COVID-19 protocols.
- Normal District-approved practices and processes relating to field trips will resume, and participants will follow COVID-19 protocols.

### Playgrounds/Recess

Playgrounds will reopen for students with social distancing to the extent possible.

# **Parents' Corner**

### POSITIVE PARENTING

Living in today's fast-paced society often leaves parents wondering how to relate to and support their children. Many find themselves utilizing very few disciplinary techniques before exerting physical consequences.

The national volunteer service organization, offered a list of alternative techniques to use when rearing and disciplining children. They encouraged parents to utilize the following strategies when teaching their children the appropriate ways to behave. Parents can:

- Model-exhibit the behavior you want to see and share your own experiences with your
- Establish Clear Consequences-tell your child exactly what will happen if a rule is
- Praise-acknowledge when your child follows the rules
- Confrontation-ignoring the behavior does not fix the problem
- Lead Family Discussions-talk about what is going on with your children
- Establish Logical Consequences-let the punishment fit the crime
- Implement the First/Then Rule—inform your child that he/she must complete the task before moving on to something he/she would like to do.
- Be Consistent-stick to the rules you set

### Keepin' Up With Those Books/Devices

Parents, please remind your child of his/her responsibility to prevent damage to his/her textbooks. Textbooks should be properly secured in lockers and should never be left in the halls, outside, or in a teacher's classroom. Students should never give anyone their locker combinations and should make sure their lockers are locked after each visit. # Test to Protect Our Schools

### Covid-19 Testing for Schools: An Overview and FAQ for Parents and Guardians

- Q: Why is Shelby County Schools (SCS) offering testing services in the school? A: SCS is committed to a safe environment for all students that supports on-going, in-person instruction as they return this fall.
- O: Who will be providing the testing services?
- A: Shelby County Schools will partner with Poplar Healthcare and Christ Community Health Services for this initiative.
- Testing services offered are completely voluntary and will require parental consent
- Q: Does a parent/legal guardian have to be present for the test?

  A: A parent or legal guardian is not required to be present for the test, but a parental consent form must be completed prior to testing. The parental consent form only has to be completed once and will be applicable for the entire 2021-22 academic school year.
- Q: What type of test will be administered to students?
  A: The test will consist of a shallow nasal swab. This is a molecular test, referred to as the polymerase chain reaction (PCR). The PCR test is considered the gold standard of testing bec of its accuracy.
- Q: How often will my child be tested?
  A: Students will be tested on a rotational, systematic schedule throughout the school year.
- Q: How long will it take for results to be returned? A: Results will be returned within 24 hours.
- Q: How will I receive my test results?

  A: An email will be sent to the parent's or guardian's primary email address of record as listed in PowerSchool. This email will state "Results are Ready." Once opened, the recipient will be redirected to a secure portal to access results.
- Q: What happens if the test result is positive?
- A: If your child tests positive, he/she will be relocated to the safe room and directed home to self-isolate and seek medical attention, as necessary.
- Q: Does anyone else have access to my child's results?
- A. Students' health information will only be shared in accordance with HIPAA guidelines and the consent and waiver forms signed by the parent or guardian.
