Every Student Succeeds Act (ESSA) Parents' Right-To-Know

All parents have the right to request the following:

- A teacher's professional qualifications, which includes: state qualifications, licensure, grade/s certification, waivers
- A teacher's baccalaureate and /or graduate degree, fields of endorsement, previous teaching experience
- A paraprofessional's qualifications
- An assurance that their child's name, address, and telephone listing not be released to military recruiters

All parents will receive information on the following:

- Their child's level of achievement in each of the state academic assessments
- Their option to request a transfer to another school within the district if their child is the victim of a violent crime at school
- Their right to timely notification that their child has been assigned, or has been taught for four or more consecutive weeks by, a teacher who is not highly qualified

ACTION STEPS

Woodstock Middle School will have an assessment team that will meet and create common assessments for ELA, math, science, and social studies bi-weekly to monitor students' progress in learning and applying the state standards as well as to determine the reteaching of state standards to students.

Woodstock Middle will implement "Data Nights" each semester and Parent-Teacher Conferences each semester and upon requests of the administration, teachers, or parents to keep parents informed of the schools' academic progress.

The family engagement specialist will establish partnerships with adopters to connect Woodstock Middle School with community resources that support the teaching and learning environment and the overall well-being of students to assist with increasing the progressive discipline support rate.
