# **Attendance Policy:**

#### Missing/Make Up Work Policy:

- The highest grade a student earns for making up work missed for an unexcused absence is 69 (D).
- For excused absences, students are expected to make-up work missed within a reasonable time (at most one day of make up for each day missed). (Ex., If a student misses Thursday and Friday of a week and returns to school on Monday, the student has Tuesday and Wednesday to complete the assignments, and work is due on Thursday)
- For unexcused absences, one day of make-up shall be allowed for all consecutive days of absence (unless otherwise extended by the school or extended based on law or policy), beginning the day after the student's return to class Students and parents should work with teachers for assistance in completing make-up work
- Assessments will be made up under the supervision of the classroom teacher or designee
- Teachers must provide the make-up work and determine the grade during the same nine weeks the work was assigned
- It is the responsibility of the student and parent to retrieve the provided make-up work and to complete it in the allotted time
